This sold out event one was one for the record books. 175 attendees, including 44 Wild and Scenic River Heroes, descended on the City Club for an evening of celebration, reflection and looking ahead. The evening program featured speakers Mark Dubois, For



Founder; Steve Evans, FOR Wild & Scenic Consultant; Eric Wesselman, FOR Executive Director; and a very special performance by Grammy award winning singer and songwriter, and FOR River Advocate, Laurie Lewis.

This year we paid homage to the many heroes who helped to designate over 2000 miles of river into the State and Federal Wild and Scenic Systems over the last 50 years. These folks worked together to build a strong community of river advocates whose reach surpasses the boarders of California and we are truly honored that so many could attend this commemorative event.
