Friends of the River's program work seeks to protect and restore California rivers through public engagement, education, government relations, and litigation when necessary. In 2020, the organizational program work focused on the three following areas:

PROTECTING RIVERS FROM COSTLY AND ENVIRONMENTALLY DESTRUCTIVE DAMS AND DIVERSIONS.

Friends of the River continued to lead the conservation group's response to proposed surface water projects. A critical part of that work includes managing the Storage Response Group (SRG), which is a multi-stakeholder coalition that works on dam projects sparked by state and federal subsidies that transitioned to virtual bi-weekly Zoom convenings during the COVID-19 pandemic. Some of the notable projects include the proposed Del Puerto Canyon Dam, the Shasta Dam Raise, proposed Temperance Flat Dam, and proposed Sites Dam. Friends of the River organized allied organizations, generated earned media, and filed litigation to halt progress on the Del Puerto Canyon Dam.

PROMOTING HYDROPOWER AND DAM POLICY, SYSTEM, AND OPERATIONAL REFORM.

Friends of the River worked on a number of relevant hydropower and pumped hydropower project relicensing proceedings, legislative and legal issues to protect, enhance, and restore California's rivers, watersheds, and communities affected by hydropower operations. Most of the work was dedicated to the tracking and contributing to the response to the expanding Clean Water Act Section 401 waiver issue throughout California, including filing litigation challenging the Federal Energy Regulatory Commission's waiver of Section 401 on hydropower projects in the Yuba and Merced River watersheds. Friends of the River also provided leadership on priority projects such

as Oroville and Pacific Gas and Electric's American River projects.

BUILDING PUBLIC SUPPORT FOR RIVERS.

Friends of the River connected many people to rivers through our rafting and canoe programs, helped cultivate the next wave of leaders by recruiting additional organizers for our River Advocacy Training School, and produced several educational and outreach "Riverside Chat" videos during the COVID-19 pandemic.
